1. General description

The 74LVC138A decodes three binary weighted address inputs (A0, A1 and A2) to eight mutually exclusive outputs ($\bar{Y}0$ to $\bar{Y}7$). The 74LVC138A features three enable inputs ($\bar{E}1$, $\bar{E}2$ and $\bar{E}3$). Every output will be HIGH unless $\bar{E}1$ and $\bar{E}2$ are LOW and $\bar{E}3$ is HIGH. This multiple enable function allows easy parallel expansion of the 74LVC138A to a 1-of-32 (5 to 32 lines) decoder with just four 74LVC138A ICs and one inverter. The 74LVC138A can be used as an eight output demultiplexer by using one of the active LOW enable inputs as the data input and the remaining enable inputs as strobes. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.




Fig. 1. Logic symbol




Fig. 2. IEC logic symbol




Fig. 3. Functional diagram




Fig. 4. Pin configuration SOT109-1 (SO16)





Fig. 5. Pin configuration SOT403-1 (TSSOP16)








Fig. 10. Package outline SOT109-1 (SO16)




Fig. 11. Package outline SOT403-1 (TSSOP16)




Fig. 12. Package outline SOT763-1 (DHVQFN16)
