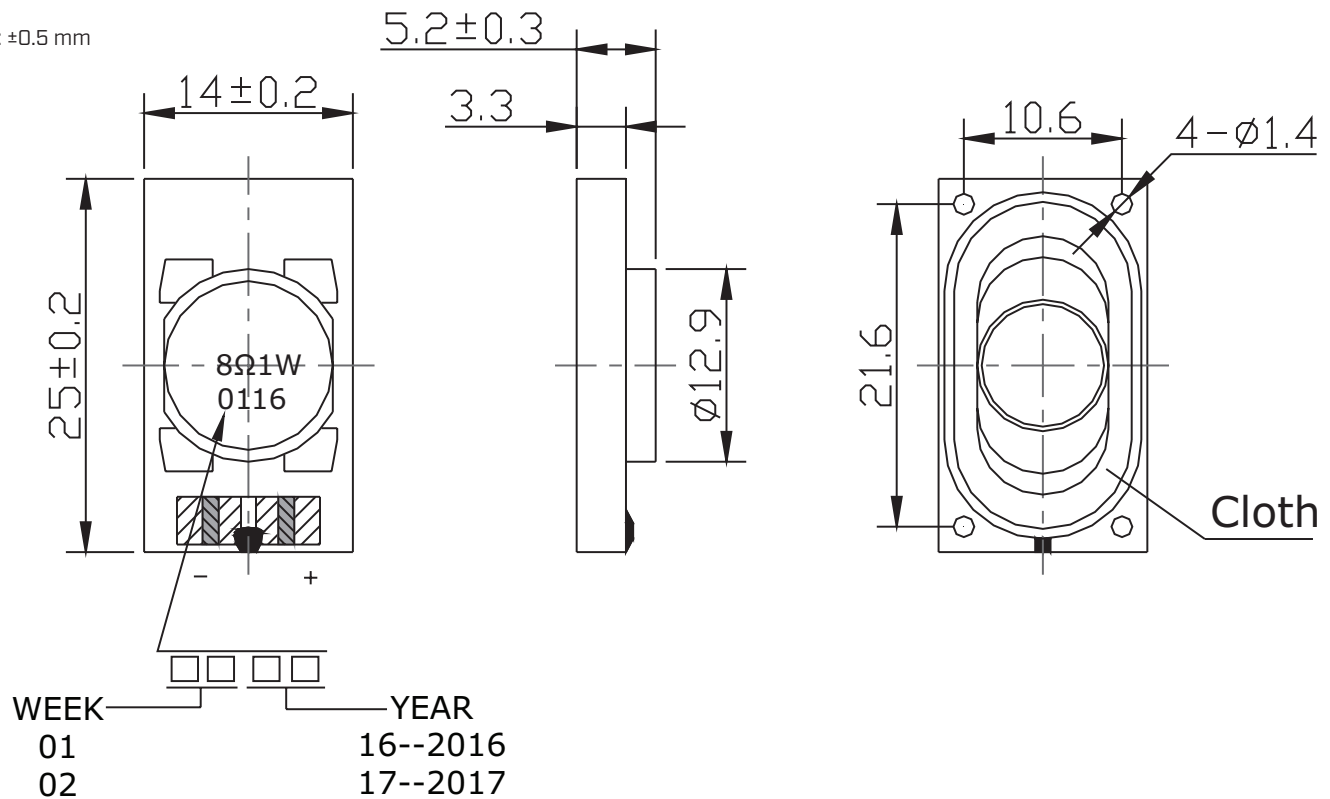

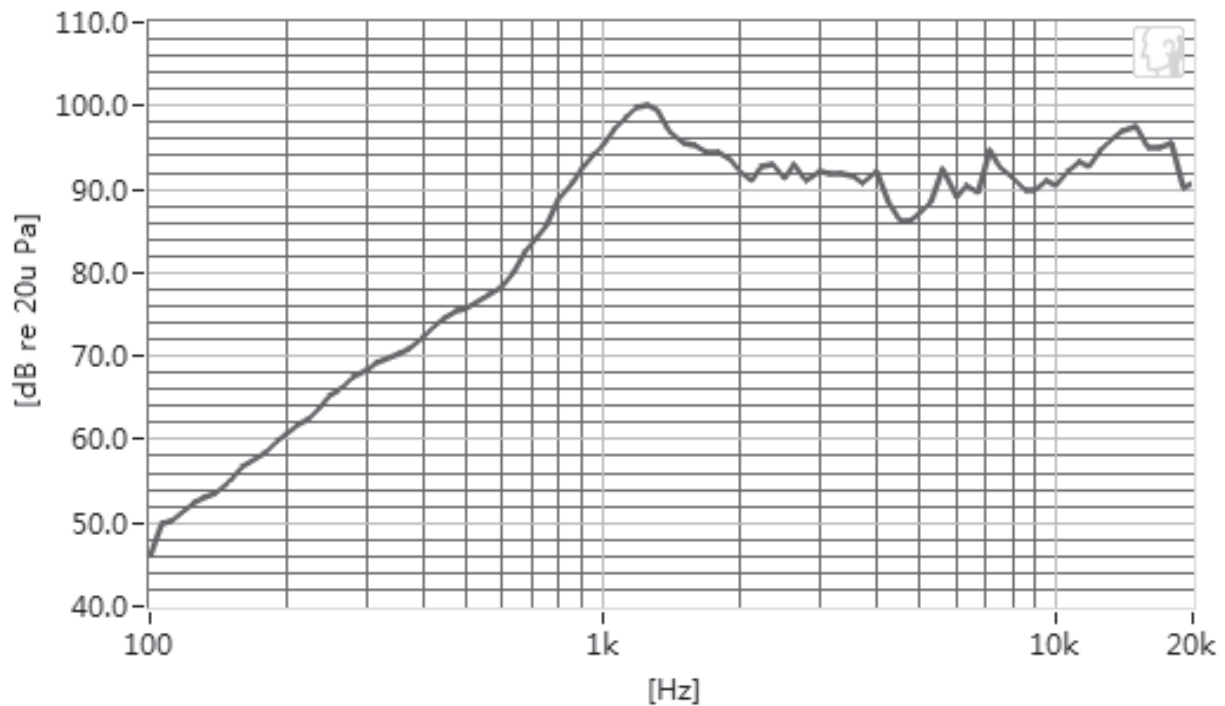

FREQUENCY RESPONSE CURVE

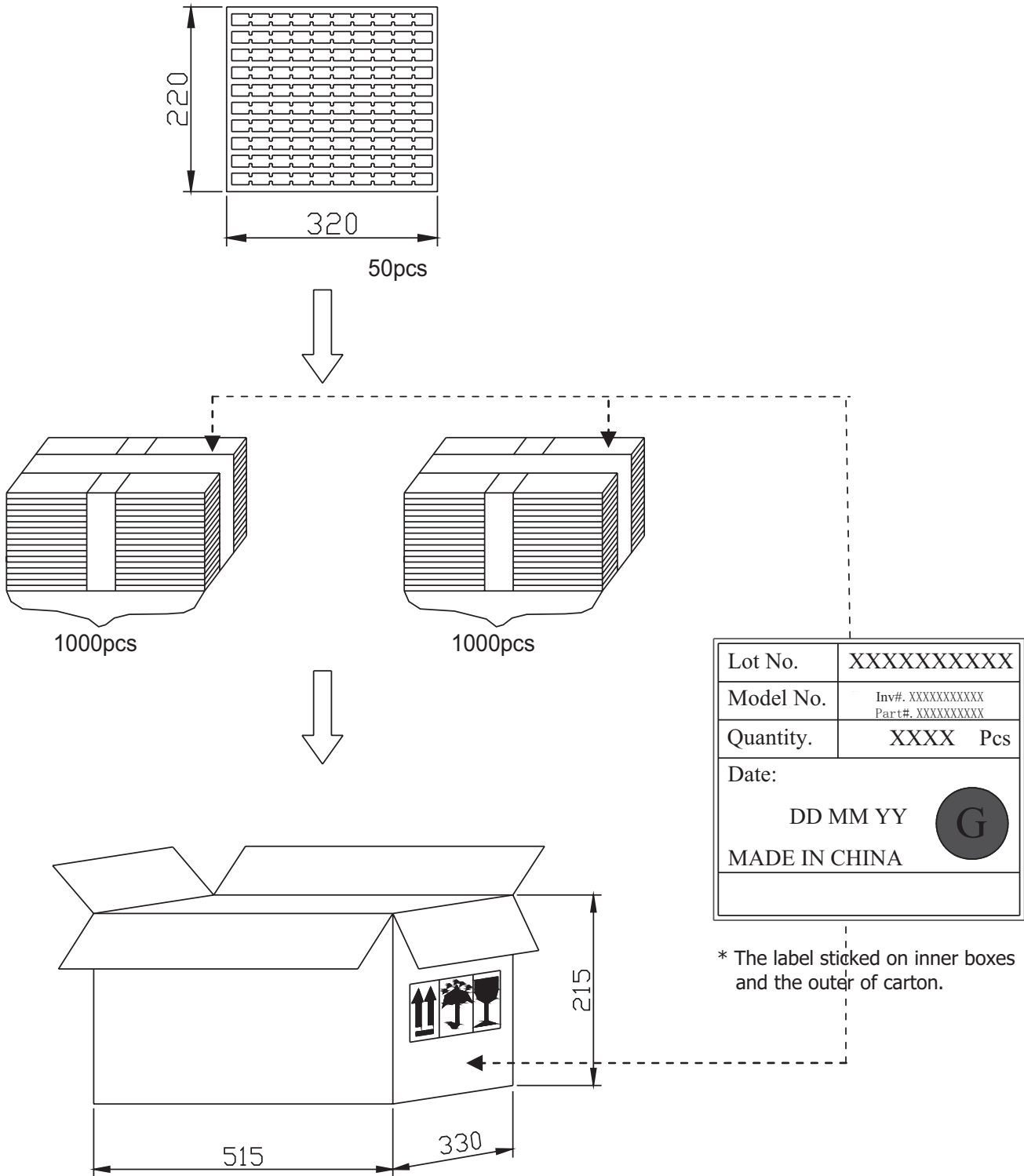
Frequency Response.Magn dB re 20.00 μ PA (at 1W / 0.1 m)
