




RELATIVE INTENSITY vs. WAVELENGTH





SPATIAL DISTRIBUTION













REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

- The maximum number of reflow soldering passes is 2 times.
 Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.




REEL DIMENSION (units: mm)
