Other soldering methods are not recommended as they might cause damage to the product.


Reflow Soldering Profile For Lead-free SMT Process.




NOTES:

3. Number of reflow process shall be 2 times or less.


### Recommended Soldering Pattern (Units : mm; Tolerance: ± 0.1)



### Reel Dimension




### Tape Dimensions (Units : mm)
